
**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF

WASHINGTON, ADOPTING AN INTERAGENCY AGREEMENT
WITH PACIFIC COUNTY DEPARTMENT OF PUBLIC WORKS
TO INSTALL WATER MAIN ON 245TH STREET**

WHEREAS, the Board of Commissioners wishes to install water main along 245th Street from the intersection with U Street and SR 103; and

Whereas, the Pacific County Department of Public Works has offered to install the water main through an Interagency Agreement for an estimated cost of \$25,500, now, therefore,

BE IT RESOLVED by the Board of Commissioners of North Beach Water District, Pacific County that the Interagency Agreement attached hereto and incorporated herein as "Exhibit A" is hereby adopted and the General Manager is authorized to execute the Interagency Agreement.
