**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF NORTH BEACH DISTRICT, PACIFIC COUNTY, WASHINGTON, ADOPTING THE NORTH BEACH WATER DISTRICT'S 2016 REGULAR MEETING CALENDAR, AGENDAS, AND NOTICE OF ADJOURNMENT**

**WHEREAS**, RCW 42.30.070 requires the North Beach Water District Board of Commissioners (Board) to establish the time and place of its regular meetings by resolution; and

**WHEREAS** RCW 42.30.070 further requires the Board to adjourn any regular meeting that fall on a holiday, to be held on the next business day, and

**WHEREAS** RCW 42.30.077 requires the Board to make the agenda of each of its regular meetings available online no later than twenty-four hours in advance of the published start time of the meeting, and

**WHEREAS** RCW 42.30.090 provides the Board the option to djourn any regular or special meetings to a time and place specified in an Order of Adjournment, provided the General Manager or Board Secretary declare the meeting adjourned and cause appropriate notice of the adjournment, and

**WHEREAS**, the Board desires to establish meeting times and places that will be consistent and convenient for the public to attend; now, therefore

**BE IT RESOLVED** by the Board of Commissioners of North Beach Water District, Pacific County, Washington as follows:

**Section 1.** No regular meeting will be scheduled on a holiday or at a time or place when attendance by the public would be precluded due to inconvenience in venue or timing.

**Section 2.** The Agenda for all regular and special meetings will be posted to the District's website at least twenty-four hours prior to the scheduled start time of the meeting.

**Section 3.** In the event a regular, special, adjourned regular, or adjourned special meeting must be adjourned the General Manager or Board Secretary will cause the following steps be taken:

A. The General Manager will cause an Order of Adjournment will be written that clearly states the time and place of the meeting being adjourned and the time and place of the meeting is being adjourned to.

B. 
