RESOLUTION 17-2016

A RESOLUTION OF THE NORTH BEACH WATER DISTRICT OF PACIFIC COUNTY, WASHINGTON, WAIVING COMPETITIVE BIDDING REQUIREMENT FOR PROCUREMENT OF USED DUMP TRUCK.

WHEREAS, on December 21, 2016 North Beach Water District (District) adopted Resolution 27-2015 approving its 2016 Operating Budget (Budget); and

WHEREAS, the Budget included the purchase of a used Dump Truck and Mini Excavator; and

WHEREAS, due to market conditions for used equipment conducting an open bid process would require the District expend considerable time and expense to develop and implement significant bidder qualification and evaluation criteria with no guarantee that the bidder criteria and equipment specification will result in the most qualified vendors being a low bidder for a used Dump Truck; and

WHEREAS, due to the unique nature of used equipment procurement, it is impractical for the District to prepare an equipment specification that would result in a responsible competitive bidding process; and

WHEREAS, The District's General Manager (GM) has made a diligent comparative search of the inventories of used equipment vendors in the Pacific Northwest for appropriate Dump Trucks; and.

WHEREAS, the District is authorized under RCW 39.04.280(1)(b) to waive the public works competitive bidding requirements otherwise applicable under Chapter 39.04 RCW for procurements involving "special facilities" or "special market conditions";

NOW, THEREFORE, THE NORTH BEACH WATER DISTRICT BOARD OF COMMISSIONERS, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Pursuant to RCW 39.04.280(1)(b) the Board of Commissioners (Board) of the District hereby declares the procurement of a used Dump Truck a "special facility" and finds the existence of "special market conditions". In light of the factual basis set forth in the "Whereas" clauses above, incorporated and adopted in full by this reference, the Board finds that the market conditions under RCW 39.04.280(1)(b) exist. These market conditions include, but are not limited to, economic and schedule considerations involved with the evaluation of qualified vendors and the impracticality of developing bid

specifications and conditions for use in comparing used equipment as required for competitive bidding in Chapter 39.04 RCW.

Section 2. In accordance with RCW 39.04.280, the competitive bidding requirements of Chapter 39.04 RCW are hereby waived for the procurement of the used Dump Truck described in Section 3.

Section 3. The Board awards a procurement contract for a used Dump Truck to:


