Commissioner Sheldon requests the general manager look into the possibility of using the tsunami warning system speakers to make boil water announcements.

The general manager states that he would take the information from the meeting to update the District's policies and improve how the District notifies customers as a whole and high risk commercial customers in particular.

## VII. Resolution 17-2016 Procurement Of A Used Dump Truck

The general manager gave a presentation on Resolution 17-2016.

Commissioner Sheldon moved to adopt Resolution 17-2016 authorizing the general manager to spend up to \$50,000 including tax and title on a used dump truck.
