**WHEREAS**, Wirkkala Construction Inc. submitted the lowest responsive bid at \$14,676.74.



**LIMITED PUBLIC WORKS CONTRACT**

**THIS CONTRACT** is entered into by and between the NORTH BEACH WATER DISTRICT (District) and Wirkkala Construction Inc. (Contractor).

The District and the Contractor agree as follows:

**ARTICLE 1. WORK.**

Work shall consist of furnish, install, compact base and top rock at the District's Wiegardt Wellfield located in Ocean Park, Washington as specified in the Contract Documents.

**ARTICLE 2. CONTRACT TIME.**

The Contractor shall complete all Work required by the Contract within 30 business days.

**ARTICLE 3. LIQUIDATED DAMAGES.**

For each working day beyond the Substantial Completion Date:

For each working day beyond the Physical Completion Date:

----- (\$50.00)

**ARTICLE 4. CONTRACT PRICE.**

The District shall pay the Contractor the amount(s) set forth in the Proposal (\$14,676.75) for completion of the Work in accordance with the Contract.

**ARTICLE 5. CONTRACT.**

The Contract, which comprises the entire agreement between the District and the Contractor concerning the Work, consists of the following:

- This Agreement;
- The Call for Bids;
- The Contractor's Proposal including the bid, bid schedule(s), information required of bidder, and all required certificates and affidavits;
- The Contract Provisions and Specifications, including 2014 WSDOT Standard Specification as herein referenced;
- The Plans (or drawings) consisting of 3 sheets, as listed in the index on sheet G-2 of 7, C-6 of 12 and CD-3 of 3 of the Plans;
- Addenda numbers 1 inclusive; and
- Change Orders issued after the effective date of this Agreement.

There are no Contract Documents other than those listed in this Article 5. The Contract may be amended only in writing by Change Order as provided in the Contract.

**ARTICLE 6. MISCELLANEOUS.**

The Contractor specifically waives any immunity granted under the State Industrial Insurance Law, RCW Title 51, which is specifically acknowledged by the Contractor. \_\_\_\_\_ (Contractor's initials)

The Contractor shall not assign any rights under or interests in the Contract, including but not limited to rights to payment, without the prior written consent of the District. Unless specifically stated in a written consent to an assignment, no assignment will release or discharge the Contractor-assignor from any duty or responsibility under the Contract.

The Contract is binding upon the District and the Contractor, and their respective partners, successors, assigns and legal representatives.
