

**NORTH BEACH WATER DISTRICT OF PACIFIC COUNTY, WASHINGTON
RESOLUTION NO. 4-2022**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE NORTH BEACH WATER DISTRICT, PACIFIC COUNTY, WASHINGTON, ADOPTING A POLICY FOR MISCELLANEOUS FEES AND CHARGES.

WHEREAS, North Beach Water District (the “District”) provides water service to its customers, developer extension projects and District projects (“Services”); and

WHEREAS, the District incurs certain direct and indirect costs associated with the provision of the Services in order that the Services may be properly provided; and

WHEREAS, the District Board of Commissioners previously established policies, fees and charges for miscellaneous fees and charges by the adoption of Resolution No. 4-2022 on August 22nd, 2022; and

WHEREAS, increase in labor and material costs warrants an adjustment in miscellaneous fees and charges; now therefore, and

WHEREAS, the District Board of Commissioners finds that the Fees and Charges, as set forth in this Resolution, are reasonably related to the overall cost of providing the Services and paying the Costs, and that imposition thereof is necessary and appropriate. Now, therefore,

BE IT RESOLVED, by the North Beach Water District Board of Commissioners, that they hereby ratify, confirm, approve and adopt all changes to the District's rate and charges as recommended and adopt the revised and updated Consolidated Rate Schedule in the form presented and attached, effective August 22nd, 2022.

BE IT RESOLVED FURTHER that to the extent that rates and charges appearing on the attached consolidated rate schedule differ from previously adopted rates and charges of the District, the rates and charges appearing on the attached schedule shall prevail; and

BE IT RESOLVED FURTHER resolution No. 4-2022 and Consolidated Rate Schedule adopted thereby is hereby superseded accordingly.

Exhibit “A”

Equipment Service Charges, Labor & Parts

- Backhoe \$50.00/hr. Includes cost of fuel and other necessary operating supplies.
- Excavator \$50.00/hr. Includes cost of fuel and other necessary operating supplies.
- Dump Truck \$50.00/hr. Includes cost of fuel and other necessary operating supplies.
- Vac-Con \$60.00/hr. Includes cost of fuel and other necessary operating supplies.
- Other Large Equipment \$25.00/hr. Compressor, Hole Hog, Hydraulic Power Unit, etc...
- Other Small Equipment \$15.00/hr. Jackhammer, Whacker, Generator, Pumps, Tapping Machine, Pressure Washer, Chainsaw, Hydraulic Tools, etc....

Labor Rates:

- Labor at \$60.00 an Hour per employee.

Parts:

- Parts associated with task are charged at costs plus 10%.
