A. Flushing, hydrants, and fireflow.

Mr. Berlien presented a slide show that covered the reason for flushing, desired outcome, how to decide on the velocity with which to flush, the District's general flushing velocity, fire flow testing, and acquiring fire flow data by actual flow testing vis-à-vis hydraulic modeling. Mr. Brundage advised that the Fire District would like to have more accurate information on where existing hydrants are and their flow capacity prior to making decisions on placing new hydrants within the system. In conclusion and after much discussion, Mr. Berlien will work with the Fire District on

scheduling flow testing for a couple of hydrants come fall flushing and provide data on hydrant maintenance.
