III. Adopt agenda:

Mr. Sheldon moved to adopt the agenda as presented. Ms. Brake seconded the motion.

V. Action items:

A. Approval of minutes (September 21, 2009 meeting).

B. Consideration of approval of liens against properties with delinquent accounts and/or satisfaction of liens.

C. Consideration of Resolution 24-2009 regarding support of the Pacific County All Hazard Mitigation Plan.

Mr. Berlien explained how support of the Pacific County Hazard Mitigation Plan would affect the District. By participating in and supporting the Plan, the District would have access to FEMA mitigation funds when they become available. Further discussion ensued on the District's mitigation considerations and emergency preparedness.

VI. Discussion items:

A. 2010 Draft Budget

Mr. Berlien informed the Commissioners that the 2010 Draft Budget was for their review. A public hearing on the Budget would be held at the November 2009 Regular Board Meeting. After the public hearing and Commissioner input, the final draft would be presented to the Commissioners at the December 2009 Regular Board Meeting.

B. Sole Source Aquifer designation.

Mr. Berlien requested input from the Commissioner as to information on population growth and land use for the North Beach Peninsula. The Commissioners provided several recommended contacts.



C. Voluntary contributions to assist low-income customers.

After discussion by the Commissioners, staff was directed to gather information on how other local agencies administered their assistance programs.

D. Service installation costs, mainline extensions, and reimbursements.
Mr. Berlien notified the Commissioners that staff would be working over the next couple of months updating the Districts Rules and Regulations to better reflect the RCW's for water districts.

E. North Wellfield generator.

Mr. Berlien informed the Commissioners that based on input from the District's electrician; the North Wellfield should be able to run off the Katolight generator. The electrician is putting together a quote on the cost to connect additional wells to the generator. Further discussion ensued on how the current system is set up, how it performs, and estimated costs associated with replacing the motor on the Caterpillar D333 generator which broke during the power outage on September 23, 2009.

VII. General Manager's report.

Mr. Berlien updated the Commissioners on the progress of the Sandridge Road line extension project.

VIII. Board member comments.

Ms. Brake provided information on conservation and rebate programs and requested that conservation programs remain as a discussion item on future meeting agendas until established.

Mr. Sheldon initiated a discussion on Automated Meter Reading (AMR). Mr. Berlien provided information on how AMR would benefit the District and the estimated cost associated with upgrading our current meters. More information will be forthcoming as the District addresses a meter replacement program next year.

IX. Future agenda items

Staff was instructed to provide Commissioners with analysis of the pros/cons of repairing/declaring as surplus the Caterpillar D333 generator as per discussion of agenda item 6E.

As per Ms. Brakes comment under agenda item 8, establishment of conservation and rebate programs is to be included on future meeting agenda. In addition, Ms. Brake request the establishment of a low-income assistance program remain as a discussion item on future agendas.

Mr. Williams requested staff look into a resolution for mandatory hookup to the District. Discussion ensued on the authority the District has to issue such a requirement and what effect said resolution would have. After discussion, Mr. Sheldon requested staff acquire information on current action being taken by the State of Washington and Pacific County regarding mandatory connections to water systems.



X. Executive Session – Pursuant to RCW 42.30.110(i)(A) – one case, thirty minutes, no action. (Martell v. NBWD)

At 7:04pm, the Board of Commissioners adjourned into executive session, pursuant to RCW 42.30.110(i)(A). Ms. Reynolds, District Legal Counsel, joined via telephone. At 7:10pm the Board of Commissioners came out of executive session. No action was taken.
