- The Contract Provisions and Specifications, including 2014 WSDOT Standard Specification as herein referenced;
- The Plans (or drawings) consisting of 3 sheets, as listed in the index on sheet G-2 of 7,C-6 of 12 and CD-3 of 3 of the Plans;
- Addenda numbers 1 inclusive; and
- Change Orders issued after the effective date of this Agreement.

There are no Contract Documents other than those listed in this Article 5. The Contract may be amended only in writing by Change Order as provided in the Contract.
