- North Beach Public Development Authority
- Issued in 2006 by Cashmere Valley Bank
- Purpose of Financing – Acquisition of certain water supply and distribution facilities and improvements to such facilities
- \$2,765,000 owing when refinanced in 2013 - Refinanced amount was \$3,600,000
- Office and Facilities Building Project (2016) - Funds available for project - \$1,019,743.25
  - Feasibility Study \$6,917.47
  - Electrical Work \$13,616.84
  - Demolish Garage \$5,600.34
  - Septic System \$9,696.70
  - Building Permit \$7,127.16
  - Architect \$101,643.79
  - Building Construction \$781,149.70
  - Heat Pump Design \$1,926.51
  - Rear Lot Asphalt \$32,288.51
  - Conference Video System \$20,540.13

- Refinanced in 2021 - \$2,430,000
