I. Call to Order Special Meeting

There was discussion between the general manager and the board on the current issues happening at the South Treatment Plant.

The general manager requested that Gray & Osborne work as our engineering service on correcting the filter media at the South Treatment Plant and conduct a Pilot Study to determine what media would be required.

Commissioner Ripley made a motion to have the general manager work with Gray & Osborne on the Pilot Study for the South Treatment Plant, referred to as Job No. PR235.64, with an estimated cost of \$49,500.

Commissioner Brake seconded that motion.

Commissioner Sheldon called for a vote on the Pilot Study for the South Treatment Plant.

The motion to approve the Pilot Study for the South Treatment Plant passed unanimously.

The general manager informed the board that additional lead and copper testing was needed after the latest sampling exceeded action level.

The general manager is also going to collect samples from 40 customers so that if some of them do not follow the procedure correctly their sample will not be used.

Also, the public needs to be made aware of this issue so the general manager is going to have a public meeting to address how this issue came about.

The board agreed with the general manager on all of these issues, giving him some feedback.
