Commissioner Ripley adjourned the meeting at 5:25 p.m.

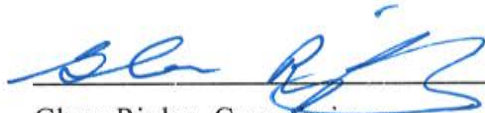
