#### A. South Wellfield Discussion

## A. Main Break on Sandridge Road

The general manager discussed with the board the main break that happened on Sandridge Road March 11th. The crew had issues with finding the valves that would isolate the break as either they did not function properly, or they were broke. Finally ended up turning water off to a larger area so that repair could be completed. The crew worked through the night to get the repair completed and water restored.

A boil water notice was issued and water samples taken to ALS in Longview the next day. The samples did come back clean and the boil water notice was lifted.
