The board brought up that if this is possible, they would like to see this in writing so that we are not stuck, “after the fact”.

Commissioner Sheldon made a motion to authorize the general manager to move ahead with the Filter Media Project at the South Wellfield for a total of \$350,000.

Commissioner Flood seconded that motion.

There was discussion on the amount of the project and whether we needed to wait for the loan determination. It was determined that we need to have the south up and running whether we get the loan and whether we can be reimbursed for the money.

Commissioner Sheldon called for a vote on moving ahead with the work on the filter media at the South Wellfield.

The motion to approve moving ahead with the Filter Media Project at the South Wellfield passed unanimously.

The general manager was also instructed to talk with the Department of Health regarding the possibility of being reimbursed for the work we do on the South Filter Media if the work is completed before the loan determination is finalized.
